## FIRST AID

<b>If in eyes</b>	<ul style="list-style-type: none"><li>• Hold eye open and rinse slowly and gently with water for 15-20 minutes.</li><li>• Remove contacts, if present, after the first 5 minutes, then continue rinsing eye.</li><li>• Call a poison control center or physician for treatment advice.</li></ul>
<b>If swallowed</b>	<ul style="list-style-type: none"><li>• Call a poison control center or doctor immediately for treatment advice.</li><li>• Have person sip a glass of water if able to swallow.</li><li>• Do not induce vomiting unless told to do so by a poison control center or doctor.</li><li>• Do not give anything by mouth to an unconscious person.</li></ul>
<b>If inhaled</b>	<ul style="list-style-type: none"><li>• Move person to fresh air.</li><li>• If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.</li><li>• Call a poison control center or doctor for further treatment advice.</li></ul>
<b>If on skin or clothing</b>	<ul style="list-style-type: none"><li>• Take off contaminated clothing.</li><li>• Rinse skin immediately with plenty of water for 15-20 minutes.</li><li>• Call a poison control center or doctor for treatment advice.</li></ul>

## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CAUTION:** Causes moderate eye injury. Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing of dust and contact with skin, eyes or clothing. ## ENVIRONMENTAL HAZARDS

## SPREADER SETTINGS\*

**Note:** The spreader settings listed above are approximate. Spreader condition, rate of walk and humidity can all vary the application rate. Broadcast (rotary) spreaders such as the Whirlybird are dependent upon the rate of walking and turning speed of the broadcast unit. Carefully calculate the area to be fertilized and make certain the proper number of pounds is applied to the area. Spreaders will vary and must be checked for accuracy.

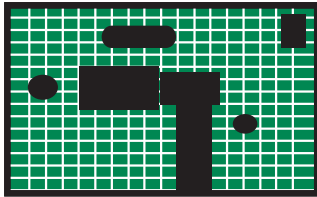

To determine how much you need, multiply the length of your lawn by its width. This equals your total square footage. Deduct any non-lawn areas (house, gardens, walkways, etc.).

**Rotary Spreader Path:** For best results, apply in a circular path starting on the outside and working toward the center. A little overlap of product will ensure complete coverage.

**Drop Spreader Path:** First, apply two border strips along the edge of each end of the lawn, overlapping slightly and shutting off the spreader before turning as you reach the edge of the border strips.

## STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Store this product only in its original container in a dry, cool, secured storage area.

**CONTAINER DISPOSAL:** Nonrefillable container. Do not reuse or refill this container.
