FIRST AID	
If in eyes	<ul style="list-style-type: none"> Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contacts, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or physician for treatment advice.
If swallowed	<ul style="list-style-type: none"> Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.
If inhaled	<ul style="list-style-type: none"> Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
If on skin or clothing	<ul style="list-style-type: none"> Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

SPREADER SETTINGS*

Note: The spreader settings listed above are approximate. Spreader condition, rate of walk and humidity can all vary the application rate. Broadcast (rotary) spreaders such as the Whirlybird are dependent upon the rate of walking and turning speed of the broadcast unit. Carefully calculate the area to be fertilized and make certain the proper number of pounds is applied to the area. Spreaders will vary and must be checked for accuracy.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Not for use on plants being grown for sale or other commercial use, for commercial seed production or for research purposes. For use on plants intended for aesthetic purposes or climatic modification and being grown in ornamental gardens or parks, or on golf courses or lawns.

USE PRECAUTIONS:
Product contains ferrous sulfate which will stain paint, concrete sidewalks and cart paths. Remove spillage immediately by sweeping or washing off sidewalks, driveways or other concrete or painted surfaces. Clean hard surfaces after application.

NORMAL MOSS INFESTATIONS
For normal control of moss, apply at the rate of 4 pounds per 1,000 square feet. A 20 pound bag covers 5,000 square feet, properly applied.

HEAVY MOSS INFESTATIONS
For heavy infestations of moss, apply at the rate of 8 pounds per 1,000 square feet. A 20 pound bag covers 2,500 square feet, properly applied.

To determine how much you need, multiply the length of your lawn by its width. This equals your total square footage. Deduct any non-lawn areas (house, gardens, walkways, etc.).

Rotary Spreader Path: For best results, apply in a circular path starting on the outside and working toward the center. A little overlap of product will ensure complete coverage.

Drop Spreader Path: First, apply two border strips along the edge of each end of the lawn, overlapping slightly and shutting off the spreader before turning as you reach the edge of the border strips.

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Store this product only in its original container in a dry, cool, secured storage area.
CONTAINER DISPOSAL: Nonrefillable container. Do not reuse or refill this container.
