#### SPREADER SETTINGS

Spreader settings given are approximate and variation can occur between identical models. The condition of your spreader, the speed at which you walk and uneven terrain may affect the rate of application. Calibrate your spreader according to the manufacturer's directions. You may also calibrate the spreader by accurately weighing a few pounds into your spreader and applying to a measured area. #### **READ ENTIRE LABEL AND USE ACCORDINGLY**

Where To Use: Jonathan Green Natural Grub & Insect Control is intended for outdoor application on lawns and landscapes.

How To Apply: Apply granules by using a hand crank, rotary or drop spreader. Uniformly apply 2 to 5 lbs. of granules per 1,000 sq. ft. Use higher application rates for severe infestations - reapply every 3-4 weeks or as needed. It is recommended to wear protective gloves if applied by hand. Wash hands with soap and water afterwards.

Grub Control: Apply early in the season to maximize protection. Apply product as indicated above and water in granules for 15 minutes to reach soil-inhabiting pests. For best results, always maintain a healthy lawn and root system.

Grubs Controlled: Japanese Beetles, Northern Masked Chafers, **European Chafers and Oriental Beetles** 

Surface Pests: Apply to surface insects when present from spring through fall. Simply spread granules over treated area and you're done. It is not necessary to water in granules for control of exposed surface pests.

Surface Pests Controlled: Carpenter Ants, Crickets, Chinch Bugs, Aphids, Mites, and other soft-bodied insects



#### For rectangular lawns

Apply two header strips across each end for a turning area. Then apply back and forth in the longest direction.

#### For irregular-shaped lawns

Apply a header strip around the entire lawn for a turning area, then apply back and forth.



Note: For rotary spreaders, each pass should be within 10 feet of each other to ensure an overlap.

- Do not leave spreader open when making turns.
- For best results, do not apply on a windy day.
- Swath will vary due to weather conditions, product used and walking speed.
- To determine how much coverage you need, multiply the length of your lawn by its width. This equals your total square footage. Deduct any non-lawn areas (house, gardens, walkways, etc.). One bag treats up to 5,000 sq. ft.

#### **STORAGE AND DISPOSAL**


Store in a cool, dry area and avoid excess heat. After partial use reseal opened bag. Discard empty bag in trash or dispose of contents/container to an approved waste disposal plant.
